SUBJECT: 2026 Department of War Cyber Excepted Service Pay Rates

- References: (a) Section 1599f of Title 10, United States Code
(b) DoD Instruction (DoDI) 1400.25, Volume 3006, "DoD Civilian Personnel Management System: Cyber Excepted Service (CES) Compensation Administration," August 15, 2017, as amended
(c) Executive Order, "Adjustment of Certain Rates of Pay," December 18, 2025

The attached tables establish 2026 Department of War Cyber Excepted Service (CES) pay rates in accordance with the personnel authorities established in references (a) and (b). The rates have been adjusted based on the 2026 General Schedule (GS) base pay table and locality percentages as authorized by the President in reference (c) and are reflected in the 2026 CES General Government and Local Market Supplement (LMS) percentages.

In accordance with section 3.4 of reference (b), the Office of Personnel Management calendar year 2026 special salary rates tables will remain in use for eligible CES employees if Targeted Local Market Supplements (TLMS) are not established for their positions. TLMS rates directly linked to a specific CES local market area and corresponding to a GS locality pay area will be adjusted automatically by the same percentage as the GS locality rates in accordance with section 3.4.g of reference (b) if GS locality pay rates are adjusted by an Executive Order or by an act of Congress.

In accordance with reference (c), the effective date for these changes is the first day of the first applicable pay period beginning on or after January 1, 2026. All rates are limited by the 2026 Executive Level IV rate of \$197,200.
