## MEMORANDUM FOR CHIEF INFORMATION OFFICER OF THE DEPARTMENT OF DEFENSE

SUBJECT: Approval of Revised Cyber Excepted Service Targeted Local Market Supplements

I approve the Cyber Excepted Service (CES) Targeted Local Market Supplement (TLMS) Pay Table A1, revised to include the Cyberspace Capability Developer (341). This change is based on the Cyber Workforce Management Board's recommendation to bring this work role into the Department of Defense (DoD) Cyber Workforce Framework and align it with Joint Cyber Training and Certification Standards. The addition of this work role will ensure personnel performing Cyberspace Effects work roles will be incentivized through CES TLMS and maintain comparable compensation with similar positions in the Defense Civilian Intelligence Personnel System.

The attached TLMS Table is approved and will be effective the first day of the first pay period beginning on or after the date this memorandum is signed, or the first pay period beginning on or after the date an incumbent's primary work role is coded as a covered role, whichever is later.

The CES TLMS pay will be reviewed annually by the DoD Chief Information Officer Workforce Innovation Directorate to ensure the rates are still necessary to meet mission requirements. Eligibility is determined by the incumbent's current status within CES, and the primary work role having been coded as one that is covered and in an applicable locality. Adjustments to CES TLMS rates are made in accordance with Department of Defense Instruction 1400.25, Volume 3006, "DoD Civilian Personnel Management System: Cyber Excepted Service Compensation Administration," August 15, 2017, as amended.
