(U) **NARRATIVE:** This message advises Combatant Commands, Services, Agencies, and Field Activities (CC/S/A/FAs) of the sunset of the Defense Collaboration Services-Classified (DCS-C) suite of collaboration tools.

1. (U) SITUATION:

1.A. (U) In alignment with Department of Defense (DOD) Unified Capabilities (UC) initiatives, the DCS-C suite of collaboration tools will be sunset on 29 FEB 2024.

1.B. (U) The DCS Program Management Office (PMO) will deprecate the DCS-C service offering, which includes the secure browser-based conference portal, web chat, and Swift chat desktop application. As part of the decommissioning process, the DCS PMO will continue limited sustainment upgrades to include system hardening and security patching as needed until DCS-C is sunset. The DCS service deprecation and eventual sunset will be synchronized with the Department's adoption of the secure DOD Microsoft Office 365 (DOD365-Sec) cloud-based services.

1.C. (U) All CC/S/A/FA users must move all meetings and engagements currently held in DCS-C to Microsoft Teams or Global Video Services-Classified (GVS-C) and download all saved DCS-C conference media files no later than 29 FEB 2024, as the meetings will not be accessible after the DCS sunset date.

1.C.1. (U) All CC/S/A/FAs that have migrated to DOD365-Sec should on-board their users to DOD365-Sec's Microsoft Teams capability. All inquiries pertaining to individual users onboarding to DOD365-Sec should be directed through their respective chain of
